When you visit our Websites, our servers record information ("log data"), including information that your browser automatically sends whenever you visit the Website. This log data includes your Internet Protocol ("IP") address (from which we understand the country you are connecting from at the time you visit the Site), browser type and settings, the date and time of your request.

With Your Consent: We may share Personal Data about you with third parties when you give us consent to do so.

Note that the consent given can be revoked at any time.

Storage of the Data

The Personal Data provided will be kept and processed by VIROSPACK for as long as we need it to provide you with your requested product(s) or to meet our commercial or legal obligations.

We make sure that we do not keep your personal data for long than is necessary or appropriate.

When we no longer need to retain your personal data, it will be deleted or be anonymised so that you can no longer be identified from it.

Your Rights

Subject to EU data protection law, you have the following rights related to your Personal data:

- **Right of Access:** If you ask so, we will confirm whether we are processing your personal data and, if so, provide you with a copy of that Personal Data

- **Right to object:** You may ask us at any time to stop processing your Personal Data, and we will do so.
- **Right to rectification:** You are entitled to ask that we correct or complete your personal data if it is inaccurate or incomplete.
- **Right of portability of data:** You have the right to move, copy or transfer personal data from our database to another. This only applies to personal data that you have provided, where processing is based on a contract or your consent, and the processing is carried out by automated means.
- **Right of restriction/limitation of processing data:** This right means that our processing of your personal data is restricted, so we can store it, but not use nor process it further.
- **Right to be forgotten:** In some cases, you have the right to have your personal data erased or deleted. You may ask us to delete or remove your Personal Data, such as where you withdraw your consent.
- **Right of Cancellation:** You can unsubscribe or opt out of our direct marketing communication at any time.
- **Right not to be subject to a decision based solely on automated decision-making:** Where we use your personal data to make an automated decision about you you have the right to object to our decision. Your right does not apply if: (i) you gave us your explicit consent to use your personal data to make our decision; (ii) we are allowed by law to make our decision; or (iii) our automated decision was necessary to enable us to enter into a contract with you.

If you have a concern about our privacy practices, including the way we handled your Personal Data, you can report it to the data protection authority that is authorized to hear those concerns.

Cookies

Access to this website may involve the use of cookies.

Cookies are small text files placed on your browser so that the server can remember certain information that may later be used.

This information allows to identify you as a specific user and allows you to save your personal preferences and technical information.
